**THE 1<sup>st</sup> BLESSED SACRAMENT YOUTH BASKETBALL CAMP** will be June 5-8 and is open to young boys and girls who will begin grades 4-8 in the fall of 2017. The camp will be run by Scott Eades who spent 5 years as an assistant coach and 8 years as the head coach at Robert Morris University in Springfield. The camp will be held at Blessed Sacrament School. Individual skills and concepts including shooting, ball handling, passing, free throw shooting, defense and post moves will be taught during the camp. Advanced techniques of team offense and defense including a daily 5-on-5 period will be stressed. Each camper will be assigned to a group by his and her age and skill. The daily schedule is extremely flexible, and since we are primarily interested in what is best for the individual, the agenda will be adjusted to suit each camper's needs. Individual instruction from area coaches and college players will be utilized at the camp. Each camper will receive a camp basketball, t-shirt, and water bottle. All proceeds will go to the BSS Athletic Department.

**RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY,  
AND PARENTAL CONSENT AGREEMENT ("Agreement")**

IN CONSIDERATION of Blessed Sacrament School organizing the BSS Basketball Camp and furnishing services, facilities, volunteers, coaches, and equipment to conduct the basketball camp and in consideration of my minor child or ward (hereinafter referred to as "Minor Child") being permitted to participate in the BSS Basketball Camp and basketball activities, including but not limited to, running, jumping, catching, dribbling, shooting, training, lessons, and instruction, (collectively referred to as "Sports Activities"), at Blessed Sacrament School, at 1725 S Walnut Street, Springfield, Illinois, 62704, I, for myself, my Minor Child, our respective personal representatives, assigns, heirs, next of kin, beneficiaries, and all other affiliated persons:

1. Acknowledge, agree, represent, and warrant that I am the parent and/or legal guardian of the Minor Child, authorized to enter into this Agreement for myself and my Minor Child, understand the nature of the Sports Activities and my Minor Child's experience and capabilities, and believe my Minor Child to be qualified, in good health, and in proper physical condition to participate in such Sports Activities. I further agree and warrant that if, at any time, I believe conditions of play to be unsafe or if I become aware of a health issue or concern with my Minor Child, I will immediately discontinue my Minor Child's further participation in the Sports Activities.

2. Fully understand that: (a) my Minor Child's participating in the Sports Activities involves risks and dangers of serious bodily injury, including permanent disability, paralysis, and death (collectively referred to as "Risks"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of my Minor Child, the actions or inactions of others engaged in the Sports Activities, the rules of play, the condition of the facilities or any equipment used, the condition in which the Sports Activities take place, or the negligence, inaction or action of the Releasees (as defined herein); (c) there may be other risks and social and economic losses, either not known to me or not readily foreseeable at this time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I or my Minor Child, our respective personal representative, assigns, heir, next of kin, beneficiaries, and/or other affiliated persons incur as a result of my Minor Child's participation in the Sports Activities.

3. Hereby release, discharge, and covenant-not-to-sue Blessed Sacrament School and the BSS Basketball Camp, their respective coaches, volunteers, administrators, agents, employees, vendors, insurance companies, accountants, and/or attorneys, other participants and their parents/legal guardians, and, if applicable, any user or occupant of the Blessed Sacrament School premises while attending the BSS Basketball Camp (collectively referred to as "Releasees" herein) from any and all liabilities, claims, demands, losses, damages, and/or causes of action of whatever nature or kind on my account caused or alleged to be caused in whole or in part by the Releasees or others, whether in law or in equity, including negligent rescue operations, and I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, losses, liabilities, damages or costs which any of them may incur as the result of such claim.

4. Hereby release, discharge, and covenant-not-to-sue, the Releasees from any and all liabilities, claims, demands, losses, damages, and/or causes of action of whatever nature or kind on my Minor Child's account caused or alleged to be caused, in whole or in part, by the Releasees or others, whether in law or in equity, including negligent rescue operations, and I further agree that if, despite this Agreement, I, my Minor Child, or anyone on behalf of my Minor Child, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation expenses, attorney fees, losses, liabilities, damages or costs which any of them may incur as the result of such claim.

5. Give my consent for the personnel, coaches, and volunteers of Blessed Sacrament School or the BSS Basketball Camp to secure emergency medical care and/or first-aid treatment, as I or my Minor Child might require while at the BSS Basketball Camp and agree to be financially responsible for the cost of any such assistance or treatment.

6. Grant permission for the personnel, coaches, and volunteers of Blessed Sacrament School or the BSS Basketball Camp to record or allow the recording of my Minor Child in the Sports Activities while at the BSS Basketball Camp, including, but not limited to, the taking of photos, videos, motion pictures, TV, or other recordings, to be used for any lawful purpose by Blessed Sacrament School or the BSS Basketball Camp, including but not limited to, the use for advertising, promotion, or commercial purposes, without compensation or reimbursement to me or my Minor Child.

**I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE, AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**
